Named one of Time's "100 Most Influential People," awarded "Outstanding Chef" and "Humanitarian of the Year" by the James Beard Foundation, José Andrés is an internationally-recognized culinary innovator, author, educator, television personality, humanitarian and chef/owner of ThinkFoodGroup. A pioneer of Spanish tapas in the United States, he is also known for his groundbreaking avant-garde cuisine and his award-winning group of 28 restaurants plus a food truck located throughout the country and in Mexico City. José is the only chef globally that has both a two-star Michelin restaurant and four Bib Gourmands. His award winning restaurants include two Michelin starred minibar by José Andrés, Jaleo, Zaytinya, J by José Andrés at W Mexico City, Bazaar Meat at SLS Las Vegas, the Bazaar by José Andrés at the SLS Hotel in Beverly Hills and South Beach, and Beefsteak, his vegetable-driven fast casual concept. Andrés is a committed advocate of food and hunger issues and is known for championing the role of chefs in the national debate on food policy. In 2012, Andrés formed World Central Kitchen, a non-profit that provides smart solutions to hunger and poverty by using the power of food to empower communities and strengthen economies. Together with World Central Kitchen and #ChefsforPuertoRico, Andrés served over 3.3 million meals in Puerto Rico following the devastation of Hurricane Maria in 2017, reaching communities in need across all 78 municipalities through 23 kitchens.

Curtis Stone is a chef, restaurateur, author, media personality, and businessman. He began his cooking career in his homeland of Australia and later honed his skills at Michelin-starred restaurants in London under renowned chef Marco Pierre White. His first solo restaurant, Maude (Beverly Hills, CA), opened in 2014 to rave reviews. Curtis opened his second restaurant, Gwen Butcher Shop & Restaurant (Hollywood, CA), with his brother Luke in July 2016. Curtis' restaurants have been honored with top accolades including Restaurant of the Year (Eater LA), Best New Restaurant & Best Restaurant (LA Weekly), Most Beautiful Restaurant in the Country (Eater National), while Curtis himself has received awards such as Chef Of The Year 2016 (Eater LA - both Editor's and Reader's Choice) and the first ever Excellence in the Culinary Arts Award from the Australian Government. He has appeared on a number of top-rated programs including Take Home Chef (TLC), Top Chef Masters (Bravo), and Food Network's All-Star Academy. Curtis is Head Judge on Top Chef Junior, an extension of the NBC Top Chef franchise, alongside host Vanessa Lachey. He hosted his first season of Moveable Feast with Fine Cooking on PBS. Curtis is a New York Times bestselling author with six cookbooks, his most recent titled, Good Food, Good Life, and is a regular contributor to several magazines and television shows in the United States and Australia. In 2016, Curtis began a new pledge to give back: #Commit2One, wherein each year he partners with an organization that is important to him and focuses the majority of his charitable time and resources to the cause.

Dr. Brennan Spiegel is the Director of Health Services Research for Cedars Sinai Health System and Professor of Medicine and Public Health at UCLA, where he teaches digital health science, health analytics, and cost effectiveness analysis.

Dr. Spiegel directs the Cedars Sinai Center for Outcomes Research and Education (CS CORE), a multidisciplinary team that investigates how digital health technologies, including wearable biosensors, smartphone applications, virtual reality, and social media, can strengthen the patient doctor bond, improve outcomes, and save money. CS CORE unites clinicians, computer scientists, engineers, statisticians and health services researchers to invent, test, and implement digital innovations for the clinical trenches, always focusing on the value of technology to patient and provider end users.

Dr. Spiegel has published more than 170 articles in peer reviewed journals. He is listed in the Onalytica "Top 100 Influencer" lists for digital health (#13) and virtual reality (#14). His research has been featured by major media outlets, including Bloomberg, CBS, NBC, LA Times, and the Wall Street Journal.

The relentless pursuit of his childhood dreams made Rob Dyrdek a professional athlete at 16 years old and propelled him into the world of business before most people entered college. His unquenchable desire to live life to the fullest pushed him to develop a strategy for success in life, not unlike the formula he created for his venture studio. Following his life plan for happiness, balance, and love while still achieving greatness in his career, Dyrdek now enjoys a fulfilling life with his family in Beverly Hills and continues to build his dream as he had not only envisioned but designed it.

Roy Taylor is Founder and Co CEO of a new stealth start up designed to make pixels intelligent. Roy is also advisor to the board of Cubic Motion the world leader in real-time model-based computer vision and digital animation, renowned for achievements in performance-driven facial capture.

In addition, Roy is a Director for the Board of BAFTA (British Academy of Film & Television Arts) Los Angeles and Technology Advisor to three film schools.

Previously he was Corporate Vice President and Worldwide Head of AMD Studios based out of Hollywood, Los Angeles. Before that Mr. Taylor ran worldwide channel sales at Advanced Micro Devices responsible for \$2 Billion annual revenue. He worked at AMD from January 7, 2013.

Prior to AMD, Mr. Taylor served as Executive Vice President and General Manager of Display Devices Division at MasterImage 3D, where he was responsible for autostereoscopic (glass-free) 3D business and ecosystem for smartphones, tablets, automotive and avionic industries. Mr. Taylor served as Vice President in many roles at NVIDIA, first as a founder of NVIDIA Europe and later internationally after a transfer to NVIDIA headquarters in Santa Clara.

Mr. Taylor is also Chair of the VR Society, Director of the Board of Governors for the Advanced Imaging Society and Technical Advisor for Immersive Technology to Dodge Chapman Film School, Beijing Film Academy and NFTS (National Film & Television School).
